RELEASE OF LIABILITY, ASSUMPTION OF RISK, INDEMNITY AGREEMENT: In consideration of being permitted to cheerlead, compete, observe, coach, officiate, work for or participate in any way in the events or activities hosted or sponsored by Midwest Your Football League (MYFL), each of the undersigned for him or herself, **his/her child**, his/her personal representatives, ward, heirs and next of kin: 1) **acknowledges and agrees** that if at any time (s)he feels anything to be unsafe, (s)he will immediately advise an official or coach of such and if necessary will leave the activity and/or refuse to participate further in the activity, 2) **hereby releases, waives, discharges and covenants not to sue** MYFL, its owners, members, directors, employees, agents or officers; promoters, participants, sanctioning organizations, officials, coaches, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the activities (hereinafter releasees) from all liability to the undersigned, his/her children, ward, personal representatives, assigns, heirs and next of kin for **any and all loss or damage**, and any claim or demands therefore on account of injury to the person or property or resulting in death or the undersigned arising out of or related to the event or activities, whether caused by the negligence or the releasees or otherwise, 3) **hereby agrees** to save and hold harmless the releasees and each of them **from any loss, liability, damage or cost** they may incur arising out of or related to the events or activities whether caused by the negligence of the releasees or otherwise, 4) **hereby assumes full responsibility** for any risk of bodily injury, death or property damage arising out of or related to the events or activities whether caused by the negligence of releasees or otherwise, 5) **hereby acknowledges the activities of the events are potentially dangerous and hazardous** and involve the risk of serious injury and/or death and/or property damage, 6) and **hereby agrees that this release and waiver of liability, assumption of risk and indemnity agreement extends to all acts** of negligence by the releasees, and is intended to be as broad and inclusive as in permitted by the laws of the State in which the event or activity is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
